**SUPPLEMENTAL DECLARATION OF LANCE CAVALLO REGARDING
(A) UPDATE ON MAILING OF THE NOTICE PACKET;
(B) UPDATE ON TELEPHONE HOTLINE AND SETTLEMENT WEBSITE;
AND (C) REPORT ON REQUESTS FOR EXCLUSION RECEIVED**

I, Lance Cavallo, declare and state as follows:

1. I am a Vice President of Class Actions at KCC Class Action Services, LLC (“KCC”). Pursuant to the Court’s September 19, 2023 Order Granting Preliminary Approval of Class Action Settlement, Approving Form and Manner of Notice, and Setting Date for Hearing on Final Approval of Settlement (“Preliminary Approval Order”), the Court approved the retention of KCC as Claims Administrator in connection with the proposed Settlement of the above-captioned litigation (the “Action”).¹ I have personal knowledge of the matters stated herein and, if called upon, could and would testify thereto.

¹ All terms with initial capitalization not otherwise defined herein shall have the meanings ascribed to them in the Stipulation and Agreement of Settlement, dated as of September 11, 2023 (the “Stipulation”).

UPDATE ON MAILING OF THE NOTICE PACKET

2. As set forth in the previously filed Initial Mailing Declaration, KCC had mailed 316,305 Notice Packets to potential Class Members and nominees as of November 13, 2023. Since the execution of the Initial Mailing Declaration, KCC has continued to receive requests from potential Class Members and nominees for copies of the Notice Packet. As a result, an additional 529 Notice Packets have been mailed or emailed such that as of December 11, 2023, KCC has disseminated a total of 316,834 Notice Packets to potential Class Members or their nominees.

UPDATE ON TELEPHONE HOTLINE AND SETTLEMENT WEBSITE

3. The Initial Mailing Declaration noted that KCC maintains a toll-free telephone number (1-866-573-1726) for Class Members to call and obtain information about the Settlement as well as request a Notice Packet. KCC has promptly responded to each telephone inquiry and will continue to respond to Class Member inquiries via the toll-free telephone number.

4. The Initial Mailing Declaration also noted that KCC maintains a website dedicated to the Settlement (www.AlexionSecuritiesSettlement.com). On November 16, 2023, KCC posted to the Settlement Website copies of the papers filed in support of (I) Class Representatives' Motion for Final Approval of Class Action Settlement and Plan of Allocation; and (II) Co-Class Counsel's Motion for an Award of Attorneys' Fees and Payment of Litigation Expenses.

5. KCC also updated the Settlement Website to reflect that the time of the Settlement Hearing was changed to 3:30 p.m. on December 20, 2023.


6. KCC will continue to maintain and, as appropriate, update the Settlement Website until the conclusion of the administration.

REPORT ON REQUESTS FOR EXCLUSION RECEIVED TO DATE

7. The Notice, Summary Notice, and Settlement Website inform potential Class Members that requests for exclusion from the Class must be addressed to *Alexion Securities Settlement*, c/o KCC Class Action Services, Exclusions, P.O. Box 5100, Larkspur, CA 94977-5100, such that they are received no later than November 29, 2023. The Notice also sets forth the information that must be included in each request for exclusion. As reported in the Initial Mailing Declaration, KCC had received no requests for exclusion from the Class as of November 13, 2023. Since that date, KCC has received one exclusion request, a redacted copy of which is attached as Exhibit A. In total, as of December 11, 2023, KCC has received one request for exclusion from the Class.

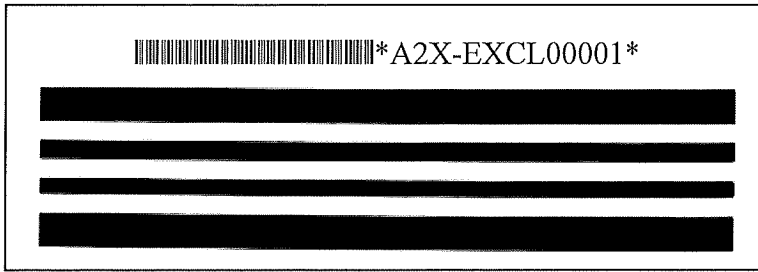

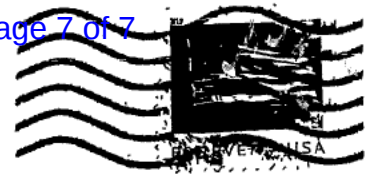

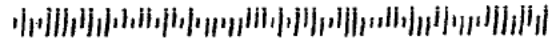
